1 Residuary legacy

The residue or part of the residue of an estate

Legacy clause wording for England and Wales

- (i) I give _____ share of my real and personal property not hereby or by any codicil hereto specifically disposed of after payment of my debts, pecuniary and specific legacies, funeral and administration expenses and any taxes in respect of my estate to Macmillan Cancer Support (registered charity number 261017) of 89 Albert Embankment, London SE1 7UQ.
- (ii) I direct that the receipt of the duly authorised officer of Macmillan Cancer Support shall be a sufficient discharge for my Executor/Trustees.

Legacy clause wording for Scotland

I direct my Executors/Trustees to pay and make over a _____ share of the residue of my estate to Macmillan Cancer Support, 132 Rose Street, Edinburgh, EH2 3JD (registered charity number SC039907) for its general charitable purposes absolutely and I direct that the receipt of the duly authorised officer of Macmillan Cancer Support shall be a sufficient discharge for my Executor/Trustees.

2 Pecuniary legacy

A fixed amount of money

Legacy clause wording for England and Wales

- (i) I give the sum of £_____ (pounds) free of tax to Macmillan Cancer Support (registered charity number 261017) of 89 Albert Embankment, London SE1 7UQ.
- (ii) I direct that the receipt of the duly authorised officer of Macmillan Cancer Support shall be a sufficient discharge for my Executor/Trustees.

Legacy clause wording for Scotland

I direct my Executors/Trustees to pay to Macmillan Cancer Support, 132 Rose Street, Edinburgh, EH2 3JD (registered charity number SC039907) the sum of £_____ pounds free of inheritance tax and other fiscal impositions for its general charitable purposes absolutely (to be paid within _____ months of my death and in priority to all other legacies given by this will or codicils hereto) (as soon as convenient after my death but without interest thereon) and I direct that the receipt of the duly authorised officer of Macmillan Cancer Support shall be a sufficient discharge for my Executor/Trustees.

3 Specific legacy

- (ii) I direct that the receipt of the duly authorised officer of Macmillan Cancer Support shall be a sufficient discharge for my Executor/Trustees.

Legacy clause wording for Scotland

I direct my Executors/Trustees to pay and make over my (short description of the property given) to Macmillan Cancer Support, 132 Rose Street, Edinburgh, EH2 3JD (registered charity number SC039907) for its general charitable purposes absolutely and I direct that the receipt of the duly authorised officer of Macmillan Cancer Support shall be a sufficient discharge for my Executor/Trustees.
