## Sponsorship form

### Make your donations work harder

Remind your sponsors to tick the Gift Aid box when they fill in the sponsorship form. This means Macmillan can claim back the basic rate tax paid by your sponsors on their donation, which is 25p for every £1 given. It doesn't cost you or your sponsor anything, but it makes your donation worth 25% more to us.

### To help us claim your Gift Aid:

- Please ask your sponsors to complete the form in legible handwriting.
- Your sponsors must fill in their home address. We cannot claim Gift Aid on work addresses.
- Unfortunately, Gift Aid does not count towards your individual fundraising total, but it does help Macmillan as a whole.

## Tick the box to make your donation worth more
