

# Longest Day Golf Challenge Prize Competition

## Terms and conditions

### Eligibility

1. All entrants (including team members) must be aged 18 years or over at the time of entry and legally reside within the UK (including Channel Islands and Isle of Man). Employees of Macmillan Cancer Support (“Macmillan”) or any of its subsidiary or affiliated companies and their immediate families and members of their households and anyone otherwise connected with operation or fulfilment of the Competition are not eligible to take part. Macmillan reserves the right to require entrants to prove that they are eligible. If a prize winner is found to be ineligible, Macmillan reserves the right to award the prize to the next eligible winner.

### Entry

2. To enter the Competition sign up to take part in Longest Day Golf Challenge at <https://longestdaygolf.macmillan.org.uk/> and deposit all sponsorship money raised by your team by POST to Macmillan Golf Team, Macmillan Cancer Support, 89 Albert Embankment, London SE1 7UQ (cheques only, no cash) and/or ONLINE on your team’s page at <https://longestdaygolf.macmillan.org.uk/> and/or via Just Giving, by 23:59 BST on 4 December 2020. Competition entries will not be accepted after this time.
3. You may only make a maximum of one entry per team into the Competition. A team consists of one team captain and up to a maximum of three team members who have participated in the Longest Day Golf Challenge. Any entries or teams with numbers in addition to this will result in disqualification. There is no other method of entry other than as specified in these Terms and Conditions.
4. After the closing date, all complete, eligible, properly submitted entries, received before the closing date will be reviewed and verified by Macmillan.

### Prize

5. The prize will be awarded to 4 (four) winning teams who have raised the most sponsorship money for Macmillan (excluding Gift Aid) received in cleared funds by the closing date. Macmillan’s decision is final.
6. The official prize is a holiday including flights and accommodation to Boavista Golf Resort & Spa in Portugal to take part in the Longest Day Golf Challenge finals in 2021. Prize includes return economy flights from London (airport to be confirmed) to Faro, Portugal, staying at the Boavista Golf & Spa Resort for 3 (three) nights in a standard room. Meals are included. Where the prize necessitates travel on a specific date, the prize winners must be available on the dates specified by the Promoter. This prize is subject to change and may be replaced by an equivalent prize or the equivalent

monetary value at the sole discretion of Macmillan. Exact dates and details will be confirmed by Macmillan no later than 6 weeks in advance of the anticipated date of departure. Macmillan accepts no liability for any changes in the details, including dates and times, of any flights, transport, accommodation, event cancellations, or other aspects of the prize, including those caused by the Covid-19 coronavirus, travel restrictions or any other cause.

7. Prize winners are responsible for paying all associated costs that are not specifically stated in these Terms and Conditions, including (where applicable) transport, spending money, insurance and all other incidentals. Prize does not include travel from/to winners' home and airport, travel insurance, drinks, or incidental costs. Prize winners and their team members must hold; a valid passport with at least 6 months' further duration and which contains no visa restrictions on the ability to travel to the destination (passport control and authorities reserve the right to refuse entry), any necessary visas, and adequate travel insurance for the dates specified. Prize winners must bring their own set of golf clubs to Portugal in order to take part in Longest Day Golf Challenge final. Prize winners are personally responsible for any personal or incidental expenses and any VAT, national and/or local tax liabilities incurred in claiming or using the prize. The Promoter will not be held liable where such charges and/or expenses are incurred, and no refund or reimbursement will be made.
8. The prize is as stated and is non-exchangeable and non-transferable. Prize winners must not change their team members before or after accepting the prize. No cash equivalent or alternative prize (in whole or in part) will be given at the request of a winner but may be given at Macmillan's discretion. By participating in the Competition you agree that the prize or alternative is awarded on an "as is" basis, and that neither Macmillan nor any of its subsidiary or affiliated companies, make any representations or warranties of any nature with respect to the prize.
9. Prize winners will be notified no later than 11 January 2021 via telephone and/or email address provided.
10. Prize winners may be required to submit valid identification before receiving the prize. If a prize winner or any team member refuses the prize, or cannot be contacted within a reasonable time, Macmillan reserves the right to award the prize to the next eligible team from the valid entries received before the closing date.

## General

11. In the event that, for reasons beyond Macmillan's reasonable control and not related to the winner, Macmillan is unable to award the prize as described in these Terms and Conditions, Macmillan reserves the right to award a prize of a similar nature and/or an equivalent value at its own discretion.

By entering the Competition you agree that any information and data (personal data) provided by you will be held and may be used by the Promoter in order to conduct the Competition, and it may be shared with Macmillan's agents, suppliers and contractors to the extent necessary for the Competition and prize to be administered. Macmillan reserves the right to modify, cancel, terminate or suspend the Competition in whole or in part, at its sole discretion, if it believes the Competition is not capable of being conducted as specified within these Terms and Conditions, or in the event of a virus, a computer bug or unauthorized human intervention or any other cause that is beyond the reasonable control of Macmillan that could corrupt or affect the administration, security, impartiality or normal course of the Competition. Neither Macmillan nor any of its subsidiary or affiliated companies are responsible for any condition, circumstances, losses, failures or delays caused by events beyond its or their control such as (but not limited to) the acts or defaults of Boavista Golf Resort & Spa or the airlines (or any other company donating the prize or part of the prize to Macmillan or supplier selected by Macmillan to provide the prize) or otherwise that may cause the Competition to be disrupted or corrupted.
