

## Free prize draw terms and conditions for Longest Day Golf Challenge 2024 (the “Prize Draw”)

By entering the Prize Draw, you agree to be bound by these terms and conditions (“**Terms and Conditions**”). Promotional materials relating to the Prize Draw, including all information on how to enter the Prize Draw, also form part of these Terms and Conditions. In the event of any conflict between any terms referred to in such promotional materials and these Terms and Conditions, these Terms and Conditions take precedence.

### 1. **The Promoter**

### 2. **How to enter and eligibility**

2.1 Anyone who registers to take part in the Longest Day Golf Challenge 2024 here: <https://longestdaygolf.macmillan.org.uk/> will automatically be entered into the Prize Draw if they register before the Prize Draw Closing Date.

2.2 You will be eligible to participate in this Prize Draw if you are eligible to participate in the Longest Day Golf Challenge competition.

2.3 The Prize Draw will run from the date and time when registration for the Longest Day Golf Challenge 2024 opens (the "**Opening Date**") to 23.59 GMT on 2<sup>nd</sup> June 2024 (the "**Closing Date**") inclusive. Any person who registers for the Longest Day Golf Challenge after this date will not be entered into the Prize Draw.

2.4 There is no fee to enter the Prize Draw.

### 3. **The prizes**

3.1 The prizes are:

1. 1 x set of clubs and bag with a fitting at PING national fitting centre in Gainsborough (*the winner is responsible for their own transport to and from the fitting*)
2. 2 x sets of 4 PING carry bags with the Macmillan logo
3. 30 x sets of 4 PING baseball caps with the Macmillan logo

There are 33 prizes and there will be 33 winners.

- 3.2 The prizes are subject to availability. There is no cash alternative for a prize.
- 3.3 The prizes are not negotiable or transferable.
- 3.4 The prize winners will be selected by a random number generator and shall be provided to the prize winners in the order of prizes listed in clause 3.1.

- 4.2 Macmillan will contact the winners personally on Monday 3 June 2024 (the “**Announcement Date**”), using the telephone number and/ or email address provided with the Prize Draw entry.
