Write your full name

Avoid ditto marks

Unfortunately, we can't claim Gift Aid on your donation if you use ditto marks (") on the form.

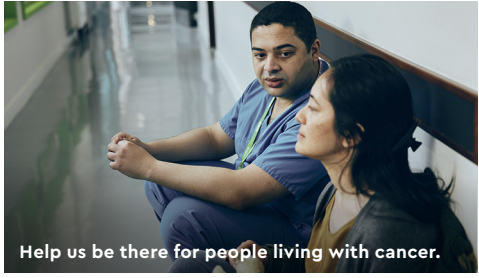
