# **Rhondda Walk 2018 Terms and Conditions**

These terms and conditions apply to all event participants registered for the **Rhondda Walk**. **These terms and conditions do not apply any other Macmillan walks**.

## DEFINITIONS

The **Rhondda Walk** is a walking event ("event") organised by the Rhondda Walk Steering Group Committee on behalf of Macmillan Cancer Support ("we", "our", "us")

Participants means anyone taking part in the walking activity and who registers with us ("Participants", "you", "your")

#### FEE £10.00

There is a registration fee of £10 for entering the event. A minimum sponsorship of £25 per walker is advised. Your registration fee is non refundable.

## REGISTRATION

In order to take part in the **Rhondda Walk** you must register online by midnight on **Sunday 1<sup>st</sup> July 2018** We will not accept entries once maximum numbers of 1,200 has been reached, so it is recommended you register in advance to ensure entry.

Children under the age of 12 years old may participate in the event subject to parental consent and being accompanied at all times by an authorised participant (ie parent, legal guardian or an adult authorised by the parent or parent guardian of the child who must also register and participate at the event) at all times during the event. We will accept registration for children under the age of 12 supported an authorised participant who must complete and return a [consent form]. The consent form must be signed by the child's parent or legal guardian and must be received by us on the day before any child under 12 may participate in the event on behalf of Macmillan Cancer Support.

Children may participate free of charge; we are pleased to present each child with a medal, however, we are unable to provide t-shirts.

#### DATA PROTECTION AND PUBLICITY

All participants, supporters and spectators, including friends and families who choose to attend the event confirm that they are happy for their names, video footage, photographs taken of them during the event to be used to publicise events held by Macmillan Cancer Support and its trading companies (Macmillan Cancer Support Trading Ltd and Macmillan Cancer Support Sales Ltd) for commercial and fundraising purposes including, but not limited to marketing material, television broadcasts, social media, advertising, publications, and other documents or mediums that may be made available to the public. Photographs of children will not be used in this manner without express written consent; unless the images are incidental, for example, children's images at the starting line. By registering a child of under 12 years old as an additional walker, you are confirming the under 12 year-old's parent or legal guardian is happy for their images to be used in this manner. #### **HEALTH AND SAFETY**

This challenge is physically demanding. If you are unsure of your physical ability to take part in the **Rhondda Walk** then you must take medical advice from a general practitioner prior to the event. We recommend that you do not take part in the event if you have received medical advice not to take exercise.

We take all reasonable steps to minimise the risk of injury to participants during our fundraising events. There is a risk assessment process in place for each and every Macmillan Committee organised walking event which aims to minimise or eliminate the risk to everyone taking part. However, by taking part in this event, you acknowledge that there may be conditions or circumstances beyond our control that can lead to unforeseen risks. If you have any concerns or queries please contact us before agreeing to take part in this event. Please be aware that the event risk assessment is measured on the basis that **Rhondda Walk** is a non-competitive walking event and we request that no participants jog or run at the event.

For health and safety reasons participants arriving late must abide by the instructions and decisions of the Event Organisers or their representatives at the walk starting area.

#### **FUNDRAISING MONIES**

All monies that you raise in connection with the **Rhondda Walk** will be held on trust for us and therefore must be passed to us. We ask that you do this as soon as practicable after the event.

This year we are walking to help Macmillan build the new Y Bwthyn Specialist Palliative Care Unit at the Royal Glamorgan Hospital, Llantrisant. The build will cost £7m and Macmillan is contributing £5m – this is our single biggest investment in Wales.

There's a small chance we'll raise more than we need for this project. If this happens, or in the very unlikely event that the project does not proceed, then your gift will be used to provide much needed help and support to people affected by cancer in the Rhondda Cynon Taf area

Dogs are welcome at the **Rhondda Walk**. However, to ensure that all participants are able to enjoy their day, we ask all dog owners to ensure that:

- Your dog is kept on a lead, under close control at all times, and any usual equipment (muzzle / harness etc) used to control your dog is employed on the day.
- That your dog has a collar with a clearly identifiable tag which sets out the contact details of its owner
- You bring adequate water supplies for your dog to keep them hydrated
- If your dog fouls, please 'scoop the poop'
- Please note, dogs are not permitted inside Rhondda College
